By means of this application I expressly declare that I accept the provisions of the Distribution Network Management Code and especially the right of Enaon EDA not to connect the respective Delivery Point if:

- a) the Connection Charges or Extension Charges are not paid, where they are payable in advance;
- b) Enaon EDA is not provided with the information required and the possibility to access the Counterparty's premises;
- c) for reasons outside of Enaon EDA's responsibility, the connection of the new Delivery Point, or the supply of Natural Gas, is deemed technically non-feasible or dangerous during the construction stage of the Outdoor Installation;
- d) there are events that constitute a situation of force majeure, as detailed in the Service Manual.

Where there are changes in the area surrounding the equipment for the regulator and/or the meter at the installation, the owner is obliged to immediately inform Enaon EDA. Furthermore, the owner is aware of and has informed the other joint owners that they are obliged not to carry out any work - construction in or on the area that will be used by Enaon EDA to lay the distribution pipeline and undertakes that this area will remain accessible and free in order for Enaon EDA to carry out the required works.

The location of the metering device is indicative and it is not necessarily the case that it will be placed at the existing connection points on the indoor installation if these connection points are located between the street line and construction line on the side of the road through which the Natural Gas Distribution Network passes. The choice of location will be made taking into account that the applicable regulations and the specifications set by Enaon EDA have been complied with.

Enaon EDA has performed a simple macroscopic (visual) inspection of the exterior of the owner's property for the purposes of preparing this proposal for the routing of the distribution line and siting of the metering device. Enaon EDA assumes no liability and cannot have any liability whatsoever in the event that the connection of the installation or the supply becomes impossible or impracticable for reasons that could not be ascertained by the above macroscopic inspection (e.g. no visible obstacles) or for reasons related to any building and/or urban planning violations, disputes between joint owners, etc. and in general for reasons which do not fall within its remit. Furthermore, Enaon EDA cannot and will not be liable for any changes, of any kind, that have taken place on the site where the property is located, after the time of review of the Owner's indoor installation design, which require modification of the design already submitted and approved or change the route of the distribution pipeline or affect in any way the connection design of the installation or affect the location of the equipment. In the event that it is not feasible or possible to implement the present design for technical reasons, a new design will be prepared by Enaon EDA or its authorised partner, taking into account the new data, as well as the owner's wishes regarding the choice of the location of the equipment which are not binding on the company. In the event that the period of time provided for in the Gas Connection Agreement for the provision of a discount on the Connection Fees, i.e. in the event that the indoor installation of the Delivery Point is not activated on time, the relevant discount will not be granted and the total amount of the Connection Fees indicated will fall due.

PRIVACY STATEMENT

Your Rights

As a data subject, you have the following rights:

- i) **information:** to receive any information about your processing in a concise, understandable, and easily accessible format
- ii) **access:** to find out which of your data are processed, the reason of process and their recipients
- iii) **rectification:** to correct any incomplete or inaccurate data we hold about you
- iv) **deletion** [also known as the right to be forgotten]: to delete them from our records, only if their processing is no longer necessary
- v) **restriction on processing:** where the accuracy of the data is contested
- vi) **portability:** to receive your data in a structured and commonly used format
- vii) **withdrawal of consent / objection:** regarding the processing of your personal data, at any time
- viii) **not be subject to a decision taken solely on the basis of automated processing, including profiling.**

If you exercise any one of your rights, Enaon EDA shall take all possible measures to satisfy your request within one (1) month from receiving it, informing you in writing about satisfaction of your request or the reasons which prevent you from exercising or us from satisfying one or more of the said rights in accordance with the General Data Protection Regulation.

Moreover, we would also inform you that you have the right to submit a Complaint to the competent Data Protection Authority.
