(c) Extraordinary technical controls of pressure measuring and regulating stations of the Delivery Points, upon request of the Distribution User or the Final Customer

This Ancillary Service is provided exclusively by Enaon EDA staff

The service is provided **free of charge** by Enaon EDA

(d) Installation of telemetry equipment at existing Delivery Points, upon request of the Distribution User or the Final Customer.

The unit charges for this Ancillary Service are referred to in (b) Installation and maintenance service of smart meter systems, including all necessary support equipment for such systems.

(e) Relocation of a section of an existing Distribution Network upon request of an Final Customer or Distribution User

Since systematization of all cases of relocation of a section of an existing Distribution Network is not feasible in this context, it is considered that the ex ante costing of this Ancillary Service would lead to an incorrect calculation of the exact cost of this Ancillary Service, as well as to unequal treatment between Final Customers and/or Distribution Users.

Therefore, the costing of the Service shall be done on a case-by-case (ad hoc) basis, depending on the materials and works required, after Enaon EDA has sent a quotation to the applicant.

(f) Modification of the External Installation upon request of the Final Customer

In accordance with paragraph 4 of Article 29 of the Code (Government Gazette B' 3726/12.08.2021), *"In case the modification request is accepted, the Operator shall send an offer for modification of an existing Delivery Point that includes: (a) the estimated cost for the modification work of the Delivery Point; (b) the estimated time for completion of the work; and (c) the amended Connection Agreement."*

On the basis of the above, it is concluded that it is possible to charge for this Ancillary Service. Therefore, the service shall be priced on a case-by-case (ad hoc) basis, depending on the materials and works required, after Enaon EDA has sent a quotation to the applicant.

(g)(i) Disconnection, (ii) dismantling or (iii) deactivation of a section or of the whole External Installation, either upon request of the Distribution User or Final Customer, or upon termination of the Connection Agreement

With regard to the Dismantling of an External Installation, according to paragraph 4 of article 34 of the Code (Government Gazette B' 3726/12.08.2021), *"The Counterparty to the Connection Agreement shall submit to the Operator a request for the Dismantling of an External Installation. The Operator shall examine the submitted request and shall inform the applicant within five (5) Working Days of the possibility or not of dismantling, the estimate of the cost of the work of dismantling the External Installation."*

Based on the above provision, the costing of the service shall be done on a case-by-case (ad hoc) basis, depending on the materials and works required, after Enaon EDA sends a quotation to the applicant.
